FAMILY MEMBERSHIP

The Family membership includes the named members and all unmarried children under the age of 23 who are full time students. The named members are responsible for the one-time initiation fee, LBYC company stock and capital improvement fees, and shall pay the full annual dues and any food/beverage minimum. Family Memberships have full reciprocity privileges with all other Florida Council of Yacht Clubs, Inc. (FCYC)

NON-RESIDENT MEMBERSHIP

A non-resident membership refers to an individual or family residing more than 60 miles from Lake Beresford Yacht Club. An individual non-resident member must meet the eligibility criteria described under Individual Membership and will be responsible for the one-time initiation fee, LBYC company stock and capital improvement fees, and shall pay one half of the annual dues and one half of any food/beverage minimum.

Non-resident family memberships must meet the eligibility criteria described under Family Membership and will be responsible for the one-time initiation fee, LBYC company stock and capital improvement fees, and shall pay the full annual dues and any food/beverage minimum charges. All non-resident members shall have **no reciprocity privileges** with other Florida Council of Yacht Clubs, Inc. (FCYC)

Fees for Non-Resident Membership

- For Family Non-Resident Membership: Refer to fee schedule for Family Membership.

INDIVIDUAL MEMBERSHIP

A single person, or married persons over the age of 65 whose spouse shall not participate in any activities or receive any benefits as a Club member, shall be eligible for membership. The Member is responsible for the one-time initiation fee, LBYC company stock and capital improvement fees, and shall pay one half of the annual dues and one half of any food/beverage minimum. Individual Memberships have full reciprocity privileges with other Florida Council of Yacht Clubs, Inc. (FCYC) clubs.

JUNIOR MEMBERSHIP

A Junior Membership includes a single person, or family, in which all individuals are under the age of 40. Junior members are responsible for LBYC Company stock and capital improvement fees, annual dues, and food/beverage minimums. The one time initiation fee will be deferred until the applicant, or any member of the family becomes 40 years of age. The deferred initiation fee will be the amount that was applicable at the time of the application, and will be payable at the beginning of the next fiscal year in which that member, or family member, attains the age of 40. Junior members shall have all the privileges (and responsibilities) associated with a Single or Family membership (whichever may be applicable), including full reciprocity privileges with all other Florida Council of Yacht Clubs, Inc.

TRIAL MEMBERSHIP

This is a limited membership allowing a person(s) to experience the club's amenities for three month period. This membership includes pool, boat ramp, slip, and clubhouse privileges.

Trial Member(s) must meet the eligibility criteria described under Individual Membership or Family Membership as applicable. Trial Member(s) are responsible for a onetime fee equal to one fourth the annual dues, food and beverage minimums, and slip fee if applicable. The following restrictions apply to this membership:

- No reciprocity privileges with other Florida Yacht Council Clubs, Inc. (FCYC)
- No Yacht Company stock issued
- No voting privileges

LIFETIME MEMBERSHIP

A Lifetime Membership includes a single or married person, in which one of the members has obtained 75 years of age, who has elected to pay a one-time fee which will cover future annual dues as long as they remain a member in good standing. Lifetime members are responsible for LBYC Company stock and capital improvement fees, the Lifetime Membership fee for dues (as predetermined by the Board of Directors), and food/beverage minimums. Lifetime Memberships are non-transferable and Non-refundable, and require a signed contract stating the details and conditions of this membership. Lifetime members shall have all the privileges associated with a Single of Family Membership (whichever may be applicable), including full reciprocity privileges with all other Florida Council of Yacht Clubs, Inc.

NAVIGATOR MEMBERSHIP

This is a limited form of membership which may be upgraded at any time. The Navigator Member is required to maintain continuous rental of a boat slip. This membership includes pool, boat ramp and clubhouse privileges subject to any required food/beverage minimums. Navigator Members are responsible for a one-time processing fee, monthly membership fee and slip fee (based on length of boat with 20 ft. minimum requirement), and metered electric, water and boat storage fees if applicable.

The following restrictions apply to this membership:

- No reciprocity privileges with other Florida Yacht Council Clubs, Inc. (FCYC)
- No Yacht Company Stock purchase required
- No voting privileges

SEASONAL MEMBERSHIP

This is a six month membership for new members only, between October 15th and April 15th for winter OR April 15th and October 15th for summer. This membership refers to an individual or family, who would like to enjoy the full use of the Club during the designated months.

The established dates for this level of membership will not be adjusted for individual circumstances. Members shall pay stated dues and any food/beverage minimum charges (as applicable for Family or Individual Seasonal Memberships).

All Seasonal Members shall have **no voting privileges**, and **no reciprocity privileges with other Florida Council of Yacht Clubs, Inc. (FCYC)**.
