TYPES OF MEMBERSHIP

The Membership application must be completed in full and submitted along with the necessary checks to the Club Office. (*Checks will not be deposited until the member is accepted.) All applications are subject to review and recommendation by the LBYC Membership Committee prior to the Board Meeting. If approved by the Board, membership will be activated the first of the following month.

FAMILY MEMBERSHIP

The Family Membership is applicable to married couples or two single individuals residing under the same address, and the member's children under 23 years of age, who are currently attending an educational institution full-time.

- **MEMBERSHIP RIGHTS:**

- A Family Membership shall enjoy:
 - A right of survivorship
 - The right of one (but not both) to cast a single vote appurtenant to the Membership
 - The right of one (but not both) to serve as an Officer or Director of the Yacht Club
 - Full reciprocity privileges with all other Florida Council of Yacht Clubs, Inc. (FCYC) Clubs

INDIVIDUAL MEMBERSHIP

LIFETIME MEMBERSHIP

Applies to an Individual, or Family, in which one of the members has obtained 65 years of age, and has elected to pay a one-time fee which will cover all future annual dues as long as they remain a member in good-standing.

- **MEMBERSHIP RIGHTS:**

- Non-transferable and non-refundable
- Requires contract stating the details and conditions of this membership
- The right to cast a single vote appurtenant to the membership
- The right of one to serve as an Officer or Director of the Yacht Club
- Full reciprocity privileges with other Florida Council of Yacht Clubs, Inc. (FCYC) Clubs

- **FEES:**

- Initiation Fee* \$1000 +TAX \$1065.00 One-Time

*Applicable to new members and members who do not have an immediately prior membership classification.

- Lifetime Dues (one-time fee): \$10,000 (+TAX) \$10,650.00 One-Time

NON-RESIDENT MEMBERSHIP

- **Applies to an Individual or Family Membership residing more than 60 statute miles from Lake Beresford Yacht Club.**
- **FEES:**
 - Refer to fee schedule for Individual Member or Family Membership.
- **MEMBERSHIP RIGHTS:**
 - The rights and privileges associated with the Family or Individual Membership
 - The right to serve as an Officer or Director, with the requirement of all meeting attendance
 - No reciprocity privileges with other Florida Council of Yacht Clubs, Inc. Clubs

SEASONAL MEMBERSHIP

Applies to a new Family or Individual Membership, between November 1st and April 30th, OR May 1st and October 31st.
This membership applies to an Individual or Family who will be using the club's amenities during a designated Season.

- **FEES:**
 - Seasonal Initiation Fee \$1000 +TAX \$1065.00 One-Time
 - Seasonal Dues \$500 +TAX (for Family) \$532.50 Season
 - Seasonal Dues \$250 +TAX (for Individual) \$266.25 Season
 - Food/Beverage Minimum (Per Month) \$50.00/Family \$25.00/Individual
 - Any Board Approved Appropriation (Per Month)* \$25.00/Family \$12.50/Individual
- *The Board Approved Assessment monthly cost is subject to change, with notice.
- Boat Slip Usage and Fees (not included in Membership)

Dues can be prorated based upon month of application, if the membership exceeds the seasonal limitation.

- **MEMBERSHIP RESTRICTIONS:**
 - A Seasonal Member may not serve as an Officer or Director of the Yacht Club
 - A Seasonal Member has no reciprocity privileges with other Florida Council of Yacht Club, Inc. (FCYC) Club
